



Limited Lifetime Warranty

TRANSOLID, LLC expressly warrants to the first retail purchaser from an authorized retailer or dealer its manufactured solid surface, quartz and granite vanity tops, kitchen sinks and shower wall products to be free of substantial defects in material and workmanship for as long as the product is owned by the first retail purchaser, subject to the limitations set forth in this Limited Warranty, provided it has been installed in accordance with the installation instructions provided by TRANSOLID, LLC, used as recommended, and not damaged due to excessive heat or moisture. This Limited Warranty does not cover damage caused by failure of any adhesive, caulk or other accessory, or failure of any caulked or filled joint or seam. It also does not cover the finish on metal frames or wooden parts after delivery. This Limited Warranty covers the product for normal interior use in the United States, Mexico and Canada and does not cover the product moved from its original place of installation. Labor charges incurred during any installations are not included under this Limited Warranty.

In addition this warranty does not cover granite tops from the natural characteristics of stone to have color variations, surface marks or blemishes. Color matches to store samples at point of purchase cannot be guaranteed. Also, while this product has been sealed at the factory to minimize staining, natural stone is porous and is not covered by any warranty against staining. The product should be resealed at least once a year as outlined in the care and cleaning instructions.

TRANSOLID, LLC will, at its option, repair, replace, or refund the purchase price of the product to the first retail purchaser if a TRANSOLID, LLC product fails due to a TRANSOLID, LLC manufacturing defect.

This Limited Warranty applies to TRANSOLID, LLC products that are purchased after January 1, 2002 and maintained as described in the enclosed care and maintenance guide. Please fill out and mail the attached registration card. You may also obtain coverage by providing proof of the date of initial purchase when you seek service. For service under this Limited Warranty, you must notify the dealer from whom you purchased the product or TRANSOLID, LLC in writing, providing your name and address, a description of the product involved the nature of the defect or failure, and proof of purchase and date of purchase. Repair or replacement shall not include any labor charges. This limited warranty is non-transferable.
